3-Year SMART Objective: By September 30th, 2014, increase the number of Pontiac residents who meet minimum recommended physical activity levels by 5% through implementation of policy, systems, environmental, and educational strategies. For adults, this means increasing the % meeting recommendations (30 minutes of moderate activity 5 or more days/week or 20 minutes of vigorous activity 3 days/week) from 52% to 57%. For children, this means increasing the % meeting recommendations (60 minutes per day at least 5 days/week) from 47% to 52%.
